## Proposed Covenant Amendment

As per section 8 of the 'DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS, RESERVATIONS, EQUITABLE SERVITUDES, GRANTS AND EASEMENTS FOR CAMELOT WOODS' dated August 6<sup>th</sup>, 1993, the owners of the 32 lots in Camelot Woods may make an amendment. A sixty percent (60%) majority of the lots must approve an amendment. The following is the proposed amendment to section thirteen (13) of the aforementioned covenants. If the required number of votes are cast in favor of the amendment then the following text and accompanying 1 page photocopy will replace the text of Section thirteen (13) of the covenants.

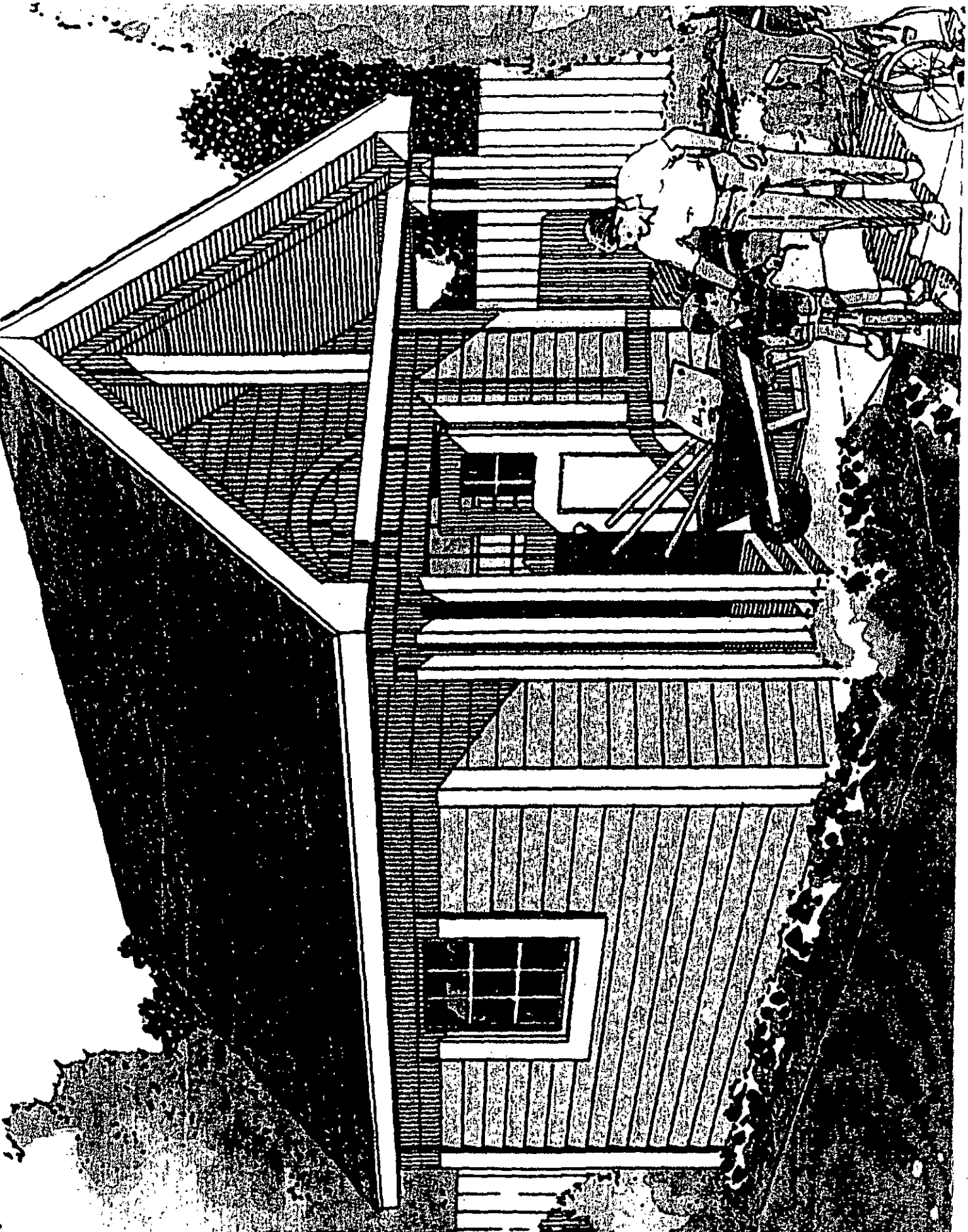
Storage Sheds  
and Out Buildings.

- (13) Storage sheds will be allowed on Camelot Woods subdivision properties as long as they meet the following conditions. All storage sheds will be of the same style with at least two windows. Storage sheds shall be either 8'X12', 10'X14', or 12'X16' in size. A pathway to the shed of not more than 6 feet wide is allowed. Roof and siding materials must match the existing home exterior in color and material. Roll-Up style doors and metal sheds are strictly prohibited. Sheds must be framed of 2X4's (min) on 16" centers (max). The foundation and floor of the shed will be concrete. The attached photocopy provides the style requirements for each shed.
